

**Somerset County Council
Butt Lake Road, Highbridge
in the Parish of Mark
(Temporary Traffic Restrictions)
Order 2020**

Somerset County Council in exercise of its powers under Section 14 (1) of the Road Traffic Regulation Act 1984 as amended and after giving notice to the Chief Officer of Police, hereby makes the following Order:

1. This Order will come into operation on the 7th day of July 2020 and will remain in force for two years. The restrictions will apply when indicated by traffic signs.
2. Except as provided in Article 4 of this Order no person will cause or permit any motor vehicle to proceed along the lengths of road specified in Schedule 1 to this Order.
3. Except as provided in Article 4 of this Order no person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the length of road as specified in Schedule 2 to this Order.
4. Nothing in Articles 2 and 3 of this Order will apply to:
 - (i) Anything done with the permission or at the direction of a police officer in uniform
 - (ii) Police, Fire and Ambulance emergency service vehicles
 - (iii) Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations
5. This Order may be cited as "Somerset County Council Butt Lake Road, Highbridge in the Parish of Mark (Temporary Traffic Restrictions) Order 2020".

**Schedule 1
Prohibition of Vehicles**

Butt Lake Road, Highbridge From the junction with Yardwall Road in an easterly direction to the junction with Green Grove.

**Schedule 2
Temporary 40mph Speed Limit**

Butt Lake Road, Highbridge From the junction with Yardwall Road in an easterly direction to the junction with Green Grove.

- b) because of the likelihood of danger to the public, or of serious damage to the road, which is not attributable to such works
