(REVOCATION AND 20MPH, 30MPH AND 40MPH SPEED LIMIT)
ORDER 2020

SOMERSET COUNTY COUNCIL in exercise of its powers under Sections 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and in accordance with Part IV of Schedule 9 to the Act of 1984 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order: -

1. This Order shall come into force on the 2nd day of July 2020 and may be cited as "Somerset County Council (Various Roads, Combe St Nicholas and Various Roads, Wadeford) (Parish of Combe St Nicholas (Revocation and 20mph, 30mph and 40mph Speed Limit) Order 2020".
2. The County Council of Somerset (Stoopers Hill, Combe St Nicholas) (30mph Speed Limit) Order 2013 will be revoked.
3. The County Council of Somerset (Combe Hill, Wadeford Hill and Wadeford Road, Wadeford (Restricted Roads) Order 2001 will be revoked.
4. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the length of road specified in Schedule 1 to this Order.
5. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the length of road specified in Schedule 2 to this Order.
6. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the length of road specified in Schedule 3 to this Order.
7. Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.

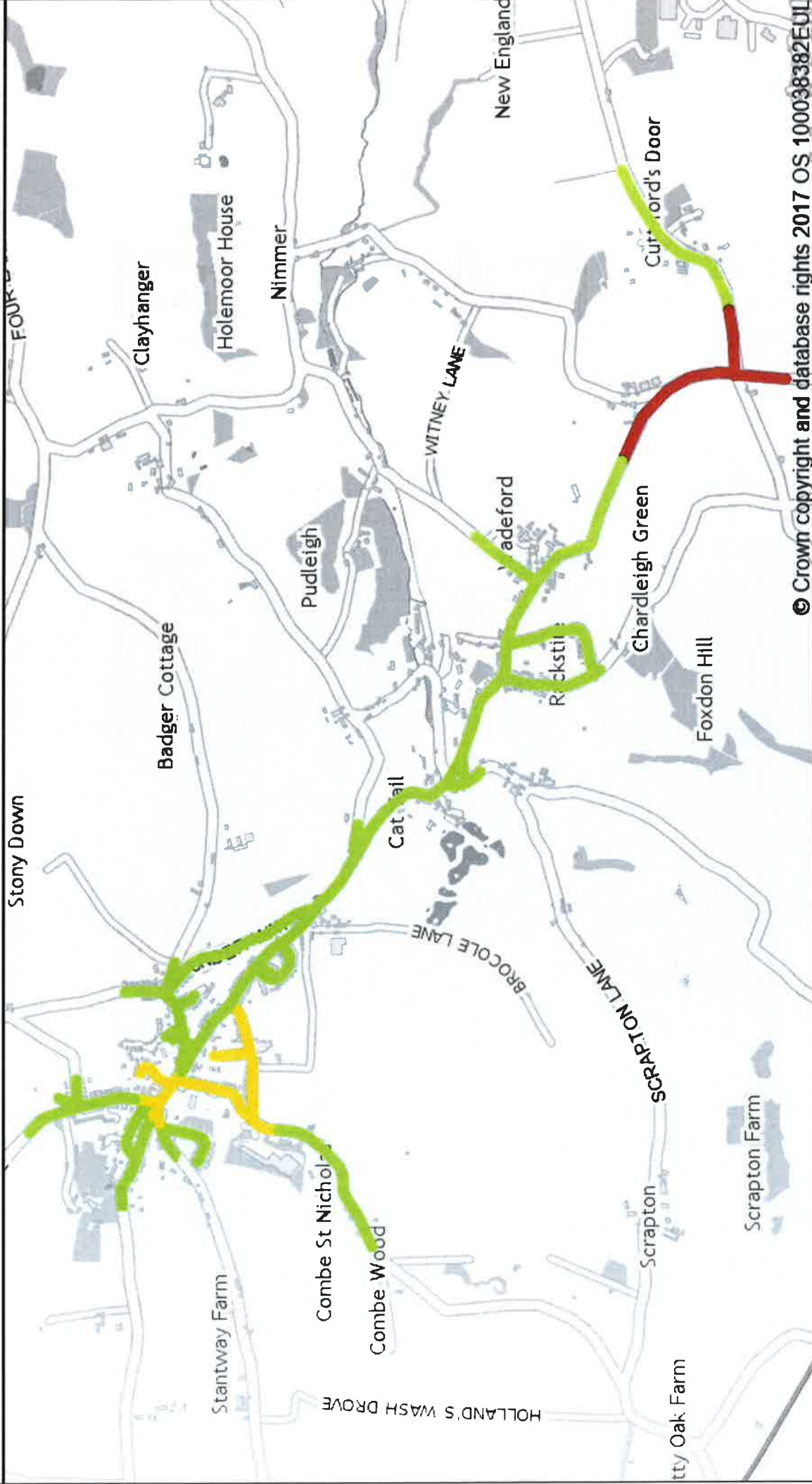
