**(REVOCATION AND 30MPH SPEED LIMIT)**  
**ORDER 2020**

SOMERSET COUNTY COUNCIL in exercise of its powers under Sections 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order: -

1. This Order shall come into force on the 28th day of May 2020 and may be cited as "Somerset County Council (Various Roads, Taunton) (Parishes of Cheddon Fitzpaine and West Monkton) (30mph Speed Limit) Order 2020".
2. The Taunton Deane Borough (Priorswood Road and Maidenbrook Roundabout) (40mph Speed Limit) 1999 is hereby revoked.
3. The provisions of any other Orders are hereby revoked but only in so far as they are affected by the restrictions imposed by this Order.
4. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the length of road specified in Schedule 1 to this Order.
5. Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations.

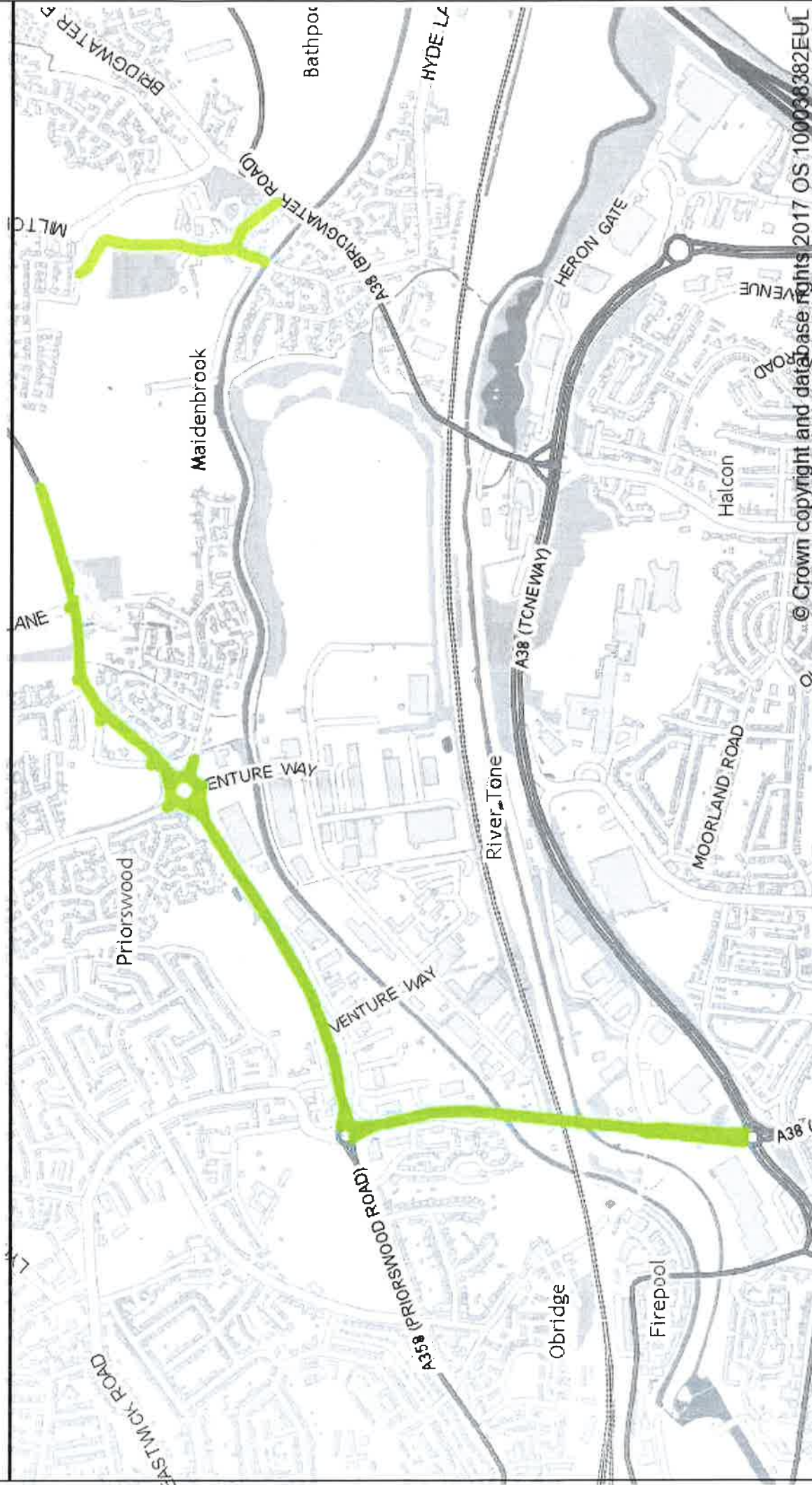
A358 Obridge Viaduct, Taunton	From Priorswood Roundabout in a southerly direction to Wickes Roundabout
A358 Obridge Viaduct, Taunton	From Wickes Roundabout in a northerly direction to Priorswood Roundabout
A3259 Priorswood Road, Taunton	From Priorswood Roundabout in a north easterly direction to the junction with Maidenbrook Lane
A3259 Priorswood Road, Taunton	From Maidenbrook Lane in a south westerly direction to the junction with Priorswood Roundabout
A3529 Yallands Hill, Taunton	From the junction with Maidenbrook Lane in a north easterly direction for a distance of 242 metres
A3529 Yallands Hill, Taunton	From a point 443 metres west of the junction with Milton Hill in a south westerly direction for a distance of 242 metres.
Nerrols Farm Roundabout	For its entire length
Waterleaze, Taunton	From Nerrols Farm Roundabout in an easterly direction for a distance of 36 metres
Nerrols Drive, Taunton	From Nerrols Farm roundabout in a northerly direction for a distance of 18 metres

Venture Way, Taunton	From Nerrols Farm Roundabout in a southerly direction for a distance of 8 metres
Nerrols Farm Lane, Taunton	From a point 30 metres north east of Nerrols Farm Roundabout in a northerly direction for a distance of 18 metres
Nerrols Farm Lane, Taunton	From a point 74 metres west of the junction with Batts Drive in an easterly direction for a distance of 18 metres
Batt Drive, Taunton	From the junction with Priorswood Road in a northerly direction for a distance of 14 metres.
Maidenbrook Lane	From the junctions with Priorswood Road and Yallands Hill for a distance of 12 metres
Dyers Lane, Taunton	For its entire length
Swingbridge, Taunton	From the junction with Dyers Lane for a distance of 66 metres in a southerly direction
