

**Somerset County Council**  
**Various Roads, Burnham on Sea and Highbridge**  
**in the Parish of Bridgwater**  
**(Temporary Road Closure and Temporary One Way System)**  
**Order 2020**

Somerset County Council in exercise of its powers under Section 14 (1) of the Road Traffic Regulation Act 1984 as amended and after giving notice to the Chief Officer of Police, hereby makes the following Order:

1. This Order will come into operation on the 9<sup>th</sup> day of July 2020 and will remain in force for eighteen months. The restrictions will apply when indicated by traffic signs.
2. The two-way system is temporarily revoked on the length of roads specified in the schedule to this Order
3. Any permanent restrictions contrary to the restrictions listed in the schedules below are temporarily revoked when signs in place
4. Nothing in Article 2 of this Order will apply to:
  - (i) Anything done with the permission or at the direction of a police officer in uniform
  - (ii) Police, Fire and Ambulance emergency service vehicles
  - (iii) Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations
  - (iv) any vehicle being used for the purpose of maintenance of the road and operations; maintenance of street furniture and infrastructure; supply of gas, water or electricity; agriculture on any land adjacent
  - (v) for residents requiring access to properties situated on or adjacent to the roads specified in this Order
  - (vi) for the purpose of loading and unloading to premises situated on or adjacent to the roads specified in this Order
5. This Order may be cited as "Somerset County Council, Various Roads, Burnham on Sea and Highbridge, (Temporary Road Closure and Temporary One Way System) Order 2020"

**Schedule 1**  
**Temporary Road Closure**

**High Street**  
**Bridgwater**

From its junction with Regent Street to its junction with Adam Street, but not including any junctions for eastbound and westbound traffic.

**High Street**  
**Bridgwater**

From its junction with South Street to its junction with Technical Street.

**Schedule 2**  
**Temporary One-Way System**

**Abingdon Street**  
**(Westbound)**  
**Bridgwater**

From its junction with Oxford Street in a westerly direction to its junction with High Street.

**Adam Street**  
**(Eastbound)**  
**Bridgwater**

For its entire length in an easterly direction.

**College Street**  
**(Westbound)**  
**Bridgwater**

From its junction with Victoria Street in a westerly direction to its junction with The Esplanade.

**Cross Street**  
**(Westbound)**  
**Bridgwater**

For its entire length in a westerly direction.

**Statement of reasons for making the Order**

- a) because of the likelihood of danger to the public, or of serious damage to the road, which is not attributable to such works  
or
- b) to facilitate social distancing in shopping areas during Covid-19.
