

Somerset County Council
Pill Road, Highbridge
in the Parishes of East Brent and Mark
(Temporary Traffic Restrictions)
Order 2020

Somerset County Council in exercise of its powers under Section 14 (1) of the Road Traffic Regulation Act 1984 as amended and after giving notice to the Chief Officer of Police, hereby makes the following Order:

1. This Order will come into operation on the 23rd day of June 2020 and will remain in force for two years. The restrictions will apply when indicated by traffic signs.
2. Except as provided in Article 4 of this Order no person will cause or permit any motor vehicle to proceed along the lengths of road specified in Schedule 1 to this Order.
3. Except as provided in Article 4 of this Order no person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the length of road as specified in Schedule 2 to this Order.
4. Nothing in Articles 2 and 3 of this Order will apply to:
 - (i) Anything done with the permission or at the direction of a police officer in uniform
 - (ii) Police, Fire and Ambulance emergency service vehicles
 - (iii) Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations

This Order may be cited as "Somerset County Council Pill Road, Highbridge in the Parishes of East Brent and Mark (Temporary Traffic Restrictions) Order 2020".

Prohibition of Vehicles**

Pill Road, Highbridge From a point 200 metres South of the junction with
the A38 Bristol Road to the junction with Vole Road
in a southerly direction

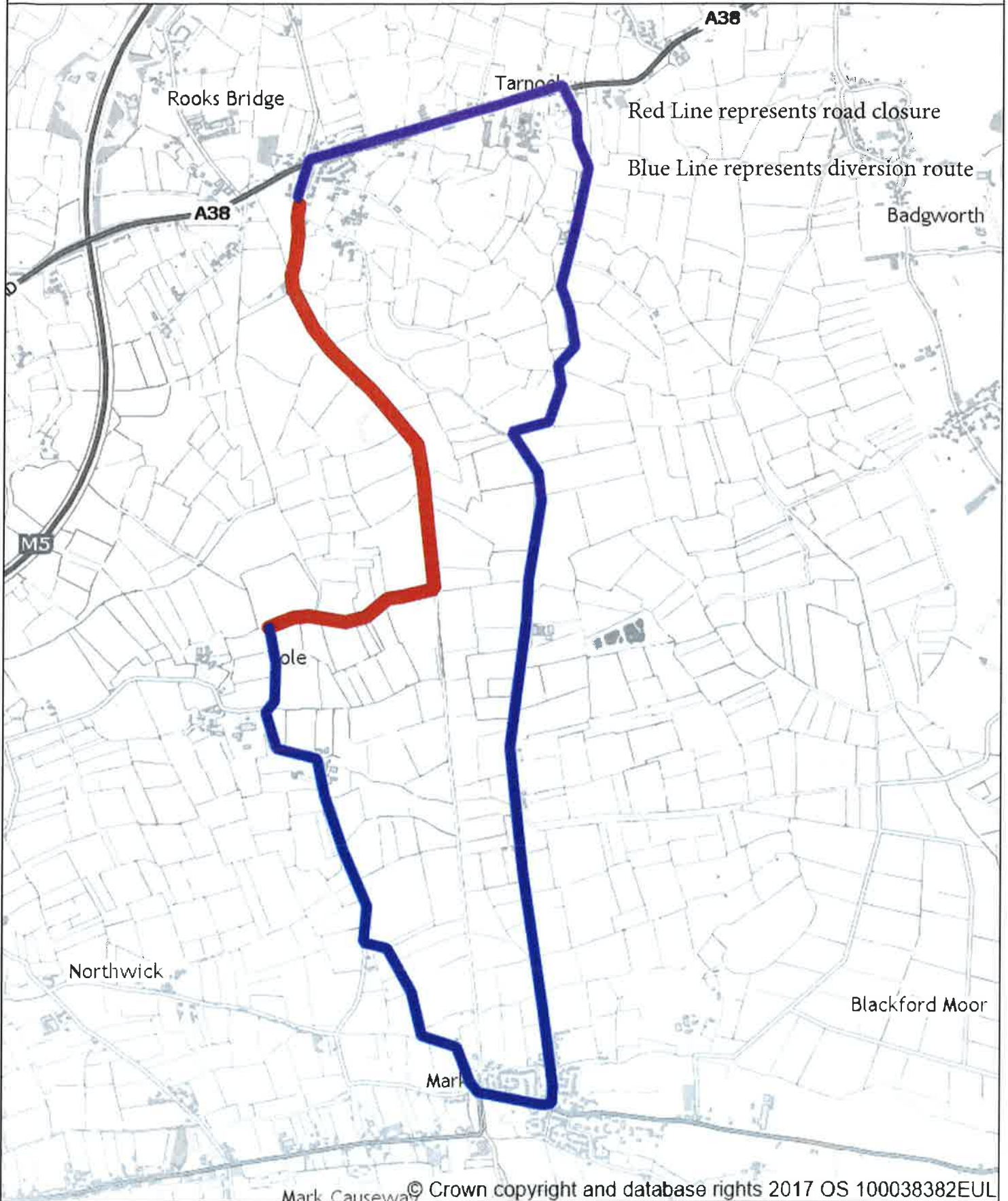
**Schedule 2
Temporary 30mph Speed Limit**

Pill Road, Highbridge From a point 1000 metres north east of the junction
with Vole Road for a distance of 200 metres in an
easterly direction

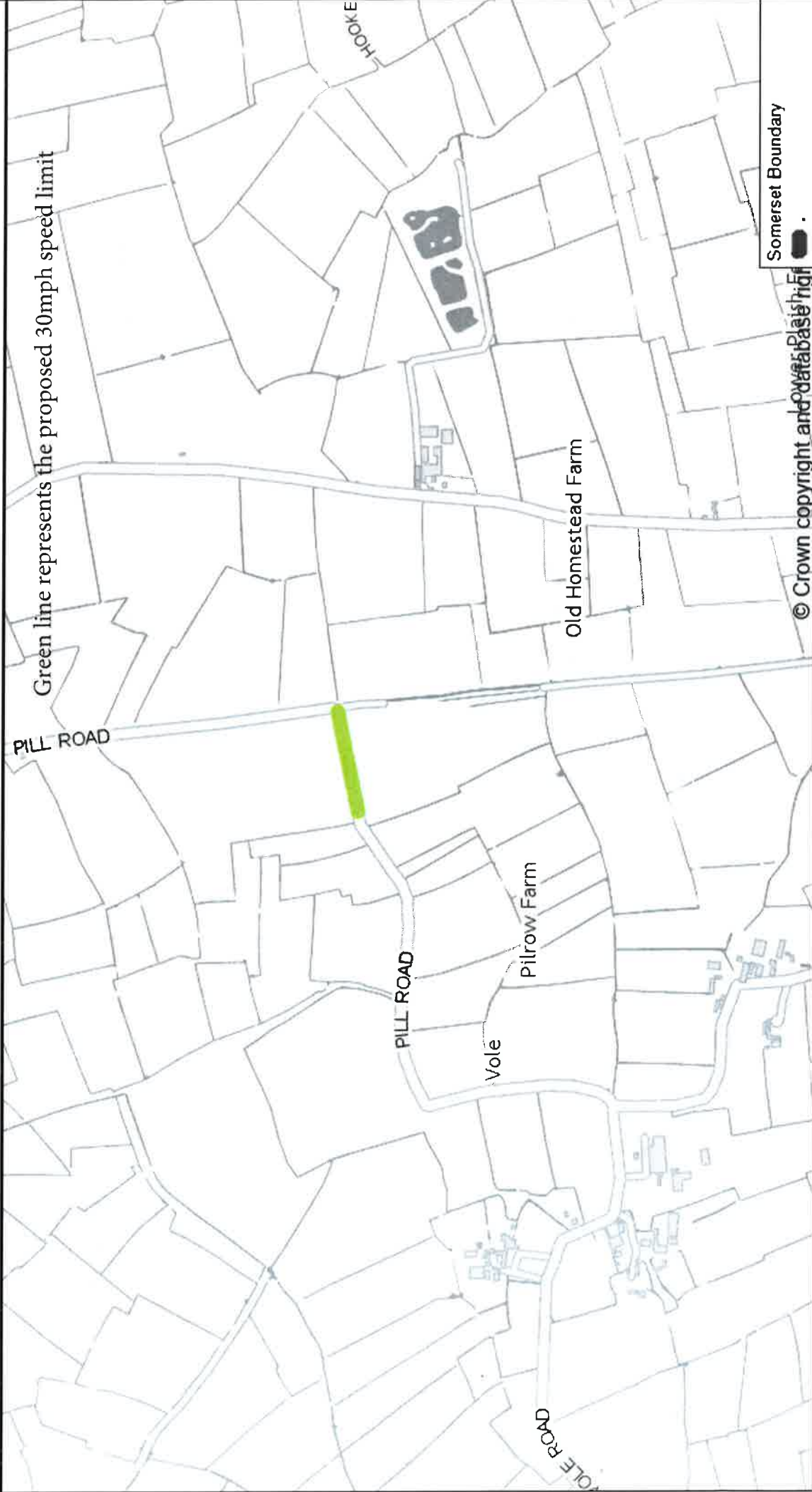
