NOTICE is hereby given that Somerset County Council proposes to make the above Order in pursuance of the provisions of the Road Traffic Regulation Act 1984, as amended, the effect of which is to introduce a 20mph Zone on the lengths of road as specified in Schedule 2 to this Order.

The County Council of Somerset, Huish and Various Roads, Yeovil (20mph Speed Limit) Order 2003 will be revoked.
