B3141 Church Road and Factory Lane, Highbridge
in the Parish of East Huntspill
(Temporary Parking Restrictions and Temporary Waiting Bay)
Order 2020

Somerset County Council in exercise of its powers under Section 14 (1) of the Road Traffic Regulation Act 1984 as amended and after giving notice to the Chief Officer of Police, hereby makes the following Order:

1. This Order will come into operation on the 9th day of June 2020 and will remain in force for four years. The restrictions will apply when indicated by traffic signs.
2. Except as provided in Article 3 of this Order no person will cause or permit any vehicle to wait, load and unload along the lengths of road specified in the schedules to this Order.
3. Nothing in Article 2 of this Order will apply to:
 - (i) Anything done with the permission or at the direction of a police officer in uniform
 - (ii) Police, Fire and Ambulance emergency service vehicles
 - (iii) Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations
4. This Order may be cited as "Somerset County Council, B3141 Church Road, Highbridge in the Parish of East Huntspill (Temporary Parking Restrictions and Loading Bays) Order 2020"

Temporary Prohibition of Waiting, Loading and Unloading

B3141 Church Road, Highbridge (North)	From a point 77 metres south of the junction with Newmans Lane for a distance of 64 metres in a southerly direction
B3141 Church Road, Highbridge (North)	From a point 9 metres south of the junction with Newmans Lane in a southerly direction for a distance of 34 metres
B3141 Church Road, Highbridge (North)	From a point 48 metres south of the junction with Newmans Lane in a southerly direction for a distance of 9 metres
B3141 Church Road, Highbridge (South)	From a point 20 metres north of the junction with Factory Lane in a northerly direction for a distance of 133 metres

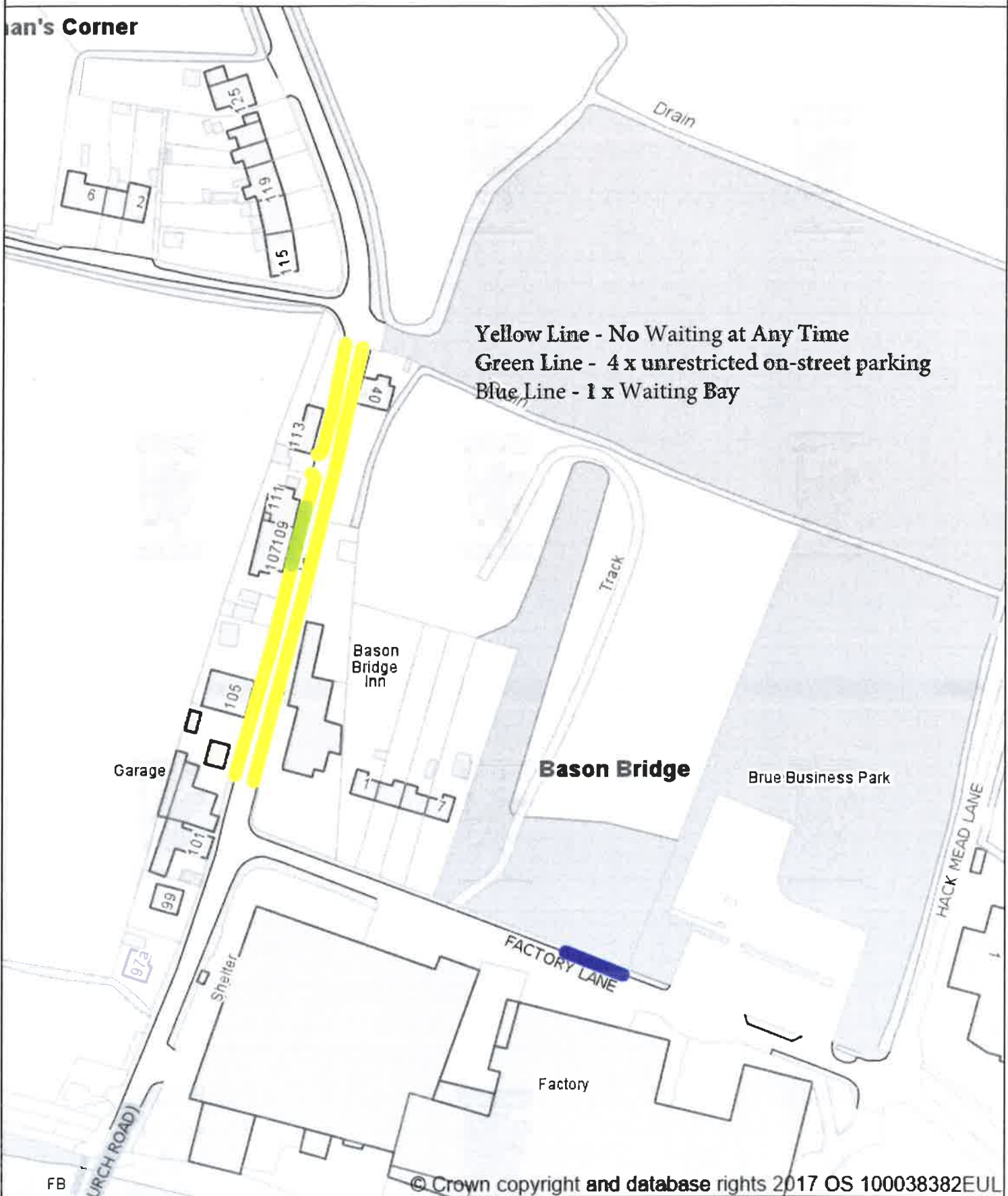
