

**Somerset County Council

Temporary Traffic Restrictions  
Order 2020**

Somerset County Council in exercise of its powers under Section 14 (1) of the Road Traffic Regulation Act 1984 as amended and after giving notice to the Chief Officer of Police, hereby makes the following Order:

1. This Order will come into operation on the 7<sup>th</sup> day of December 2020 and will remain in force for eighteen months. The restrictions will apply when indicated by traffic signs.
2. Except as provided in Article 4 of this Order No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the lengths of roads specified in the Schedule 1 to this Order.
3. Except as provided in Article 4 of this Order no person will cause or permit any vehicle to proceed in a south-westerly direction along the length of roads specified in the Schedule to this Order
4. Nothing in Article 2 and 3 of this Order will apply to:
  - (i) Anything done with the permission or at the direction of a police officer in uniform
  - (ii) Police, Fire and Ambulance emergency service vehicles
  - (iii) Vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(a) when used in accordance with regulation 3(5) of those Regulations
5. This Order may be cited as "Somerset County Council, Various Roads, Glastonbury, (District of Mendip) in the Parish of Glastonbury, Temporary Traffic Restrictions Order 2020"

**Temporary 20 mph Speed Limit**

Market Place  
Glastonbury                      For its entire length.

High Street  
Glastonbury                      From its junction with Market Place eastwards to its junction with The Archers Way, a distance of 195 metres.

**Schedule 2**  
**Temporary One Way**

Market Place  
Glastonbury                      For its entire length. Traffic to travel in a northward's direction only.

High Street  
Glastonbury                      From its junction with Market Place eastwards to its junction with The Archers Way, a distance of 195 metres. Traffic to travel in an eastward's direction only

**Schedule 3**  
**Temporary Suspension of 7.5 Tonne Weight Limit**

Chilkwel Street  
Glastonbury                      For its entire length.

Lambrook Street  
Glastonbury                      For its entire length.

### **Statement of reasons for making the Order**

- a) because works are being or are proposed to be executed on or near the road
- b) because of the likelihood of danger to the public, or of serious damage to the road, which is not attributable to such works
