SOMERSET COUNTY COUNCIL in exercise of its powers under Sections 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order: -

- 1. This Order shall come into force on the 27th day of November 2020 and may be cited as "Somerset County Council (Various Roads, Dulverton) (Parish of Dulverton) (20mph Speed Limit) Order 2020".
- 2. The provisions of any other Orders are hereby revoked but only in so far as they are affected by the restrictions imposed by this Order.
- 3. Except as provided in Article 4 of this Order no person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the lengths of road specified in the Schedule to this Order.
- 4. Nothing in Articles 3 of this Order will apply to vehicles falling within regulation 3(1), 3(2), 3(3) and 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 (a) when used in accordance with regulation 3(5) of those Regulations.
