**ORDER 2020**

SOMERSET COUNTY COUNCIL in exercise of its powers under Sections 81 to 84 of the Road Traffic Regulation Act 1984 as amended hereby makes the following Order:

1. This Order shall come into force on the 17<sup>th</sup> December 2020 and may be cited as the "Somerset County Council (A38 Wellington Relief Road, Wellington) (Parishes of Wellington Without and Wellington) (Revocation and 40 mph Speed Limit and 30 mph Speed Limit) Order 2020".
2. Somerset County Council (A38 Wellington Relief Road, Wellington (Parishes of West Buckland, Wellington Without and Wellington (Revocation of 40mph Speed Limit and 30mph Speed Limit) Order 2018 is hereby revoked.
3. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the length of road specified in Schedule 2 to this Order.
4. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the length of road specified in Schedule 3 to this Order.

**Revocation of 30 mph Speed Limit**

A38, Wellington Relief Road,  
Wellington

From a point 288 metres south west of its junction with Haywards Road for a distance of 1670 metres in a south westerly direction

**SCHEDULE 2**  
**40 mph Speed Limit**

A38, Wellington Relief Road,  
Wellington

From a point 98 metres west of its junction with Ford Street for a distance of 1002 metres in a south westerly direction

**SCHEDULE 3**  
**30mph Speed Limit**

A38, Wellington Relief Road,  
Wellington

From a point 105 metres west of its junction with Ford Street for a distance of 660 metres in a north easterly direction

Pyles Thorne Road, Wellington

From its junction with the A38 Wellington Relief Road for a distance of 221 metres in a northerly direction

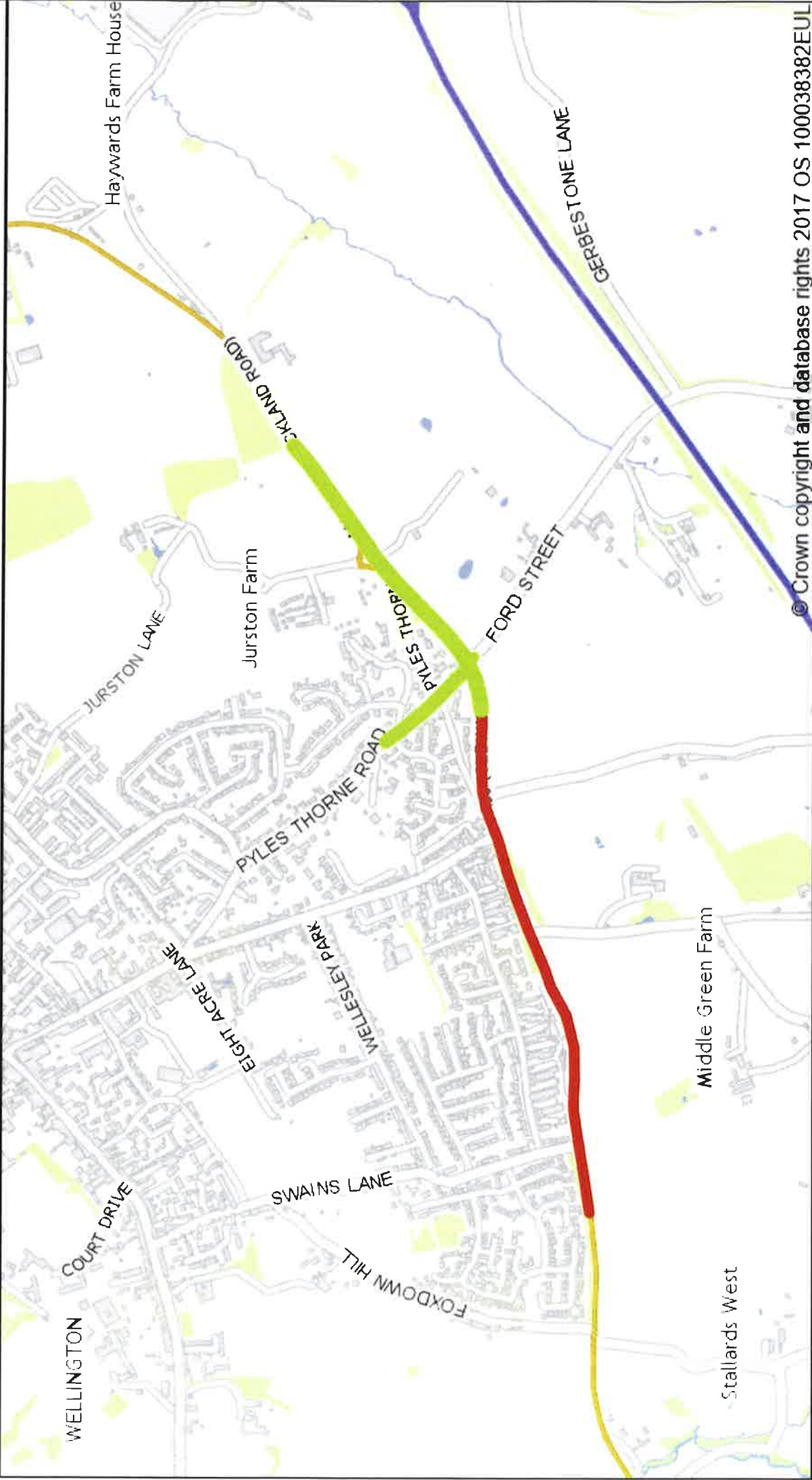
Ford Street, Wellington

From its junction with the A38 Wellington Relief Road for a distance of 12 metres in a southerly direction.
